Symbolic Corporate Adoption Terms & Conditions

- 1.1 Symbolic Corporate Adoption is valid in Malaysia only.
- 1.2 A Symbolic Corporate Adoption is valid for a period of 1 year only (from receipt of funds).
- 1.3 Full payment must be made in advance of delivery. All prices are in Ringgit Malaysia. Upon receipt of funds, a personalized certificate, information leaflet and tax exemption receipt will be sent via courier to the company address as indicated on the order form.
- 1.4 Please allow 8 weeks for delivery from receipt of order.
- 1.5 Conservation updates
 - 1.5.1 Two (2) half-yearly progress updates a year will be sent via email to the key contact person as indicated on the order form.
 - 1.5.2 A Green Heart magazine will be delivered to the company on a quarterly basis, total four (4) copies a year.
 - 1.5.3 An annual review will be delivered to the company once a year.
- 1.6 Right to communicate
 - 1.6.1 Corporations who symbolically adopt are entitled to communicate in their website, annual and/or corporate responsibility report and internal communication materials, subject to prior approval from WWF-Malaysia. Communication should not be featured on any commercial, marketing or product related brochures or materials.
 - 1.6.2 Below statement should be used for communication purposes:
'YOUR COMPANY' donated RM10,000 to WWF-Malaysia in support of tiger conservation work through a Symbolic Corporate Adoption from 2012 – 2013.
'YOUR COMPANY' donated RM20,000 to WWF-Malaysia in support of marine turtle conservation work through a Symbolic Corporate Adoption from 2012 – 2013.
 - 1.6.3 Corporations who symbolically adopt can communicate within the valid period of 1 year only (from receipt of funds).
 - 1.6.4 Usage of the Panda Logo is not allowed.
- 1.7 Turtle symbolic corporate adoption: Project site visit
 - 1.7.1 Limited to one (1) visit per company per month with a maximum of four (4) persons only during the year of funding. Advance booking of minimum 2 months is required for site visit and planning.
 - 1.7.2 Visiting season is from May – mid September.
 - 1.7.3 One (1) night accommodation for four (4) pax and 3 meals (breakfast, lunch, dinner) at Isma Beach Resort (Padang Kemuning, Tanjung Bidarah) is included in the turtle symbolic corporate adoption donation of RM20,000.
 - 1.7.4 Visits are not applicable on Mondays & Public Holidays.
 - 1.7.5 Activities include briefing on conservation work, tour of turtle information centre & hatchery, night patrolling, chance to see nesting turtle/excavate eggs (subject to availability), chance to participate in hatchling release (subject to availability). There are no guarantees in regards to seeing nesting turtles or releasing hatchlings, this is solely dependent on chance. Activities may be subjected to change depending on weather conditions.
- 1.8 Payment/Cancellation
 - 1.8.1 The donation amount for a symbolic corporate adoption: Turtle = RM20,000 or Tiger = RM10,000. Payment to be made via cheque to WWF-Malaysia.
 - 1.8.2 Once payment has been processed, the order cannot be changed or cancelled.
